# WEBSITE PRIVACY POLICY

WorkForce Central's Privacy Policy applies to all visitors to <u>www.workforce-</u> <u>central.org</u> and <u>www.workforcenavigator.org</u>. To protect online privacy, this policy explains the collection of and use of the information solely collected by these websites.

## **Policy**

WorkForce Central (WFC) will not sell, lend or otherwise provide user information to individuals, organizations or other third parties. By using the website, visitors indicate their agreement to the collection and use of information by WFC as outlined in this Privacy Policy.

### **Information Collected**

WFC collects information about visitors via its website in two ways:

- 1. Non-Personal Information: Visitors using the public areas of the website are doing so anonymously. WFC collects aggregate usage information, such as number of hits (visits) per page. WFC may track non-personal information about the visit, including the domain name and the name of the web page from which the visitor entered site, how much time is spent on each page, and the IP (internet protocol) address associated with the computer. WFC will use this information to improve services and the performance and operation of the site.
- 2. <u>Personal Information</u>: WFC will not automatically collect personal information from visitors browsing the website. The visitor must provide the information voluntarily by sending WFC an email, participating in a survey or completing an online form. The visitor may choose not to contact WFC by email, participate in a survey or provide any personal information using an online form. It is the visitor's choice to decline participation in these activities, and it will not impact the ability to browse and read or download any information provided on the site.

If personal information is requested on the website or volunteered by the visitor, state law and the Federal Privacy Act of 1974 may protect it. However, this information becomes public record once



the visitor provides it and may be subject to public inspection and copying if not protected by federal or state law.

### **Contact Lists and Newsletter Subscribers**

If while visiting the website a visitor signs up to receive a newsletter and/or periodic messages from WFC, the visitor will be asked to voluntarily provide name, company name, title and email address. The personal information provided will not be sold or shared for commercial purposes.

#### **Cookies**

This website uses "cookies." A cookie is a piece of data stored on a visitor's hard drive with the intent of enhancing their experience using the website. WFC may use cookies to improve the content delivered to a visitor while using the site. The cookies do not contain or capture any personal information. A visitor can configure a computer's browser to send a notification when a site is attempting to send a cookie, and then either accept or refuse the cookie. It is the visitor's decision to refuse or accept the cookie, and such decision will not prevent the navigation of the site.

#### **Use of Information**

WFC uses information for the following general purposes:

- 1. To respond to an inquiry generated by a visitor
- 2. To improve the services provided
- 3. To provide statistical reporting on a high level

WFC will not share personal information with any third party organization, other than as necessary to fulfill the request made by the visitor to the website.

## Opt-Out
